May kindly see the property statement online received from Sri Sunil Kumar Singh-II, Additional District Judge (POCSO), Hardoi regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2018-19 & 2019-20 in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2018-19 & 2019-20, Total Gross salary is Rs.44,28,985/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, GPF, Income Tax, Insurance policies and the balance of his savings bank account(s) is enhanced for Rs.6,14,705/- this financial year from previous year's balance, total of which is Rs.21,70,189/-. Thus, a sum of Rs.22,58,796/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial years 2009-10 which had already been seen by Hon'ble Mr. Justice Ashok Pal Singh, the then Administrative Judge, Lalitpur, placed in the misc. file of the officer and of the financial years 2010-12, 2012-14, 2014-16 and 2016-18 are currently processed & separate notes has made on case-id no.3800, 4076, 4080 and 4084 respectively.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-19 & 2019-20 vide online dated 08.12.2021. As such, there is delay in submitting the same from the part of the officer for which he has stated that *"Delay in submission of the aforesaid property statements is highly regretted. In this regard, it is also submitted that he will submit the property statements well in time, in future"* (mentioned in attachment dated 09.12.2021).

May, therefore, if approved, property statements of the financial years 2018-19 & 2019-20 of Sri Sunil Kumar Singh-II, Additional District Judge (POCSO), Hardoi be laid before Hon'ble Mr. Justice Abdul Moin, Administrative Judge, Hardoi Judgeship for His Lordship's kind perusal and orders?
