May kindly see the property statement online received from Sushri Priya Kumari Rai, Civil Judge (Junior Division), Aligarh regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial years 2018-20 (2018-19 & 2019-20), Gross income from salary is Rs.13,89,876/- and total deductions/savings/ investment against NPS, GIS, Income Tax and the balance of her savings bank account(s) is also enhanced by Rs.2,36,772/- in this financial year from previous year's balance, total of which is Rs.4,26,716/-. Thus, a sum of Rs.9,63,160/- was therefore available with herself to meet out the household expenditure in the both of the financial.

In this connection, it is submitted that the Officer has already submitted her property statement at the time of Joining into U.P. Judicial Service, which has been seen by Hon'ble Mr. Justice Manoj Misra, Administrative Judge, Deoria, in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. She has submitted movable and immovable property statements of the financial years 2018-20 (2018-19 & 2019-20) vide online dated 09.12.2021. As such, there is delay in submitting the same. In this regard, officer verbatim:

"I am submitting the statements of movable and immovable property held/acquired by me in the preceding two Financial Years. The same could not be submitted due to the nationwide lock-down and closure of District Courts because of the COVID-19 pandemic. I am hereby annexing the same for your kind information and needful. The above information is being sent on the prescribed proforma. It is, therefore, most humbly requested to you to please, by pardoning the applicant in late forwarding this application, bring this information to the knowledge of the Hon'ble High Court".

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sushri Priya Kumari Rai, Civil Judge (Junior Division), Aligarh, be laid before Hon'ble Mr. Justice Saral Srivastava, Administrative Judge, Aligarh Judgeship for His Lordship's kind perusal and orders?
