May kindly see the property statements online received from Sri Rajesh Parasher, General Manager (Law), U.P. State Industrial Dev. Corpo., Kanpur Nagar regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2016-18 (2016-17 & 2017-18) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2016-18 (2016-17 & 2017-18) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

In the financial years 2016-18 (2016-17 & 2017-18), Total income is Rs.28,07,321/- (income from salary including arrears, allowances & encashment of Rs.1,00,412/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, CPF, Income Tax, Insurance policies, repayment of home loan, mutual fund (SIP), FD, PPF and the balance of his savings bank account(s) is also enhanced for Rs.3,98,891/- this financial year from previous year's balance, total of which is Rs.21,50,985/-. Thus, a sum of Rs.6,56,336/- was therefore available with him to meet out the household expenditure of his family consisting of four members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial years 2015-16 which had already been seen by Hon'ble Mr. Justice D.K. Upadhyaya, the then Administrative Judge, Faizabad in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2016-18 (2016-17 & 2017-18) in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statements for the financial years 2016-18 (2016-17 & 2017-18) firstly vide online dated 07.12.2021. As such, there is delay in submitting the same. In this regard, officer stated that it is respectfully submitted that the above statements have not been submitted to Hon'ble Court with in prescribed time due to missing relevent documents and papers during transfer and posting from one judgeship to another judgeship. The delay caused in sending the statement is highly regretted.

May, therefore, if approved, property statements for the financial years 2016-18 (2016-17 & 2017-18) of Sri Rajesh Parasher, General Manager (Law), U.P. State Industrial Dev. Corpo., Kanpur Nagar be laid before Hon'ble Mr. Justice Mahesh Chandra Tripathi, Administrative Judge, Kanpur Nagar Judgeship for His Lordship's kind perusal and orders?
