May kindly see the property statement submitted online received from Sri Harendra Kumar Ojha, Additional District & Sessions Judge(FTC), Kanpur Nagar, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2017-19 (2017-18 & 2018-19) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2017-19 (2017-18 & 2018-19) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2017-19 (2017-18 & 2018-19), his Total income from salary & other source is Rs.33,11,148/- (income from salary is Rs.30,14,188/- & income from arrear of KVP A/c is Rs.2,96,960/-) and total deductions/savings/investments against GPF, GIS, Income Tax, PPF, Repayment of Housing Loan, LIC Policy and SSY Rs. 21,41,839/- (including enhancement of Rs.2,63,612/- in his S.B. A/cs against the balance of the previous year). Thus a sum of Rs.11,69,309/- was therefore available with him to meet out the household expenditure of his family consisting of four members in both the financial years.

It is pertinent to mention here that his father is retired govt. employee, Pension appr. 28,000.- per month.

In this connection, it is submitted that the officer has already submitted his property statements online upto the financial year 2015-17, which is also processed online before Hon'ble Mr. Justice Mahesh Chandra Tripathi, Administrative Judge, Kanpur Nagar Judgeship on old case ID no-3815.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2017-19 (2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements for the financial years 2017-19 (2017-18 & 2018-19) firstly vide his application dated 14.12.2021. As such, there is delay in submitting the same from the part of the officer. In this regard, he stated that he could not submit his property statement in time due to illness of old age father who is heart patient.

May, therefore, if approved, property statements for the financial years 2017-19 (2017-18 & 2018-19) of Sri Harendra Kumar Ojha, Additional District & Sessions Judge(FTC), Kanpur Nagar, be laid before Hon'ble Mr. Justice Mahesh Chandra Tripathi, Administrative Judge, Kanpur Nagar for His Lordship's kind perusal and orders?
