In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2019-21 (2019-20 & 2020-21), his Total income from salary is Rs.34,78,179/- and total deductions/savings/investments against GPF, GIS, Income Tax, PPF, Repayment of Housing Loan, LIC Policy and SSY Rs.16,59,749/-. Thus a sum of Rs.18,18,430/- was therefore available with him to meet out the household expenditure of his family consisting of four members in both the financial years. And the balance of his savings bank account(s) is also reduced for Rs.1,55,627/- this financial year from previous year's balance.

It is pertinent to mention here that his father is retired govt. employee, Pension apprx. 33,000.- per month.

In this connection, it is submitted that the officer has already submitted his property statements online upto the financial year 2017-19, which is also processed online before Hon'ble Mr. Justice Mahesh Chandra Tripathi, Administrative Judge, Kanpur Nagar Judgeship on old case ID no-4100.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements for the financial years 2019-21 (2019-20 & 2020-21) firstly vide his application dated 14.12.2021. As such, there is no delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial years 2019-21 (2019-20 & 2020-21) of Sri Harendra Kumar Ojha, Additional District & Sessions Judge(FTC), Kanpur Nagar, be laid before Hon'ble Mr. Justice Mahesh Chandra Tripathi, Administrative Judge, Kanpur Nagar for His Lordship's kind perusal and orders?
