May kindly see the property statement received online from Sri Abhishek Tripathi-I, Addl. Chief Judicial Magistrate, Barabanki, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2018-20 (2018-19 & 2019-20), the Gross income from salary & interest is Rs.20,25,681/- and total deductions/savings/investment against NPS, GIS, PPF, Insurances, Health check-up, donation and Income Tax is Rs.7,02,919 /- and the balance of his savings bank account(s) is also increased by Rs.15,615/- in this financial year from previous year's balance, total of which is Rs.7,18,534/-. Thus, a sum of Rs.13,07,147/- was therefore available with him to meet out the household expenditure of his family consisting three members of the financial year 2018-20 (2018-19 & 2019-20).

It is pertinent to mention here that the officer's father is a lawyer having total income Rs.3,43,390/- & Rs.10,00,000/- and mother is a housewife & farmer having total income Rs.3,91,900/- & Rs.3,72,914/- for the financial year 2018-19 & 2019-20 respectively.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2016-18 (2016-17 & 2017-18) online against Case Id : P00001462020 (Old Case Id : 727) and the same has been seen by Hon'ble Mr. Justice Ashwani Kumar Mishra, the then Administrative Judge, Sant Kabir Nagar Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial year 2018-20 (2018-19 & 2019-20) vide online dated 11.12.2021. As such, there is delay in submitting the same for which the officer stated in his letter as attachment dated 11.12.2021 that (in his verbatim) "I seek an unconditional apology and promise of future to be more aware and cautious in sending my property statements within time and request you to accept the same."

May, therefore, if approved, property statements for the financial year 2018-20 (2018-19 & 2019-20) of Sri Abhishek Tripathi-I, Addl. Chief Judicial Magistrate, Barabanki, be laid before Hon'ble Mr. Justice Manish Mathur, Administrative Judge, Barabanki Judgeship for His Lordship's kind perusal and orders?
