May kindly see the property statement online received from Smt. Shailja Rathi, Spl. Judge (E.C. Act), Azamgarh regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial years 2019-21 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial years 2019-21(2019-20 & 2020-21), Gross income from salary and other sources is Rs.30,94,882/-(income from salary is Rs.30,16,724/-, income from redemption of Kotak Standard Multicap Fund is Rs. 19,858/- and income from interest on S.B. & F.D. is Rs.58,300/-) and total deductions/ repayment/ savings/ investment against GIS, Income Tax, PPF, Share, F.D., mutual fund (SIP) and the balance of her savings bank account(s) is enhanced by Rs.8,93,609/- this financial year from previous year's balance, total of which is Rs.27,56,561/-. Thus, a sum of Rs.3,38,321/- was available with her to meet out the household expenditure of her family consisting of three members in both of the financial years.

It is pertinent to mention here that her husband Sri Ajay Kumar Singh is in cader of District Judge in Utter Pradesh, having monthly income Rs. 1,81,000/- approx.

In this connection, it is submitted that the Officer has already submitted her property statements of at the time of joining online against Old Case id no-720 and same has been seen by Hon'ble Dr. Justice Kaushal Jayendra Thaker, the then Administrative Judge, Baghpat Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2019-21(2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. She has submitted movable and immovable property statements of the financial years 2019-21(2019-20 & 2020-21) vide online dated 07.12.2021. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2019-21(2019-20 & 2020-21) of Smt. Shailja Rathi, Spl. Judge (E.C. Act), Azamgarh be laid before Hon'ble Mr. Justice Jayant Banerji, Administrative Judge, Azamgarh for His Lordship's kind perusal and orders?
