May kindly see the property statement online received from Shri Amit Kumar Singh, Addl. Civil Judge (Sr.Div.)/ACJM., Budaun, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-20 (2018-2019 & 2019-2020) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-20 (2018-2019 & 2019-2020) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2018-20 (2018-2019 & 2019- 2020), Total income is Rs.16,89,609/- and total deductions repayment/ savings/ investment against GIS, NPS, Income Tax, Home Loan installments, PPF & various policies and the balance of his savings bank account(s) is enhanced by Rs.22,701/- this financial year from previous year's balance, total of which is Rs.3,14,298/-. Thus, a sum of Rs.13,75,311/- was therefore available with him to meet out the household expenditure of his family consisting of three members in both of the financial years.

In this connection, it is submitted that the officer has already submitted his property statement related to joining which has been processed online & a separate note has been made on eservice-Id no.: P00013282021 (Old Case Id: 3435) which has been placed before Hon'ble Mr. Justice Saurabh Lavania, Administrative Judge, Budaun for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 (2018-2019 & 2019- 2020) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-20 (2018-2019 & 2019- 2020) vide online dated 10/12/2021. As such, there is delay in submitting the same. In this regard, officer has submitted a letter of delay condonation as attachment wherein he has stated that delay has occured inadvertently.
