May kindly see the property statement online received from Sri Amit Kumar, Additional Civil Judge (Sr.Div.)/ Additional Chief Judicial Magistrate, Gorakhpur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2019-21 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2019-21 (2019-20 & 2020-21), Gross income from salary is Rs. 20,18,813/- and total deductions/savings/ investment against NPS, GIS, PPF, Income Tax, Mutual Fund, Insurances and the balance of his savings bank account(s) is also enhanced by Rs.2,52,270/- in this financial year from previous year's balance, total of which is Rs.9,31,654/-. Thus, a sum of Rs.10,87,159/- was therefore available with him to meet out the household expenditure of his family consisting of two members in the both of the financial year.

It is pertinent mention here that Officer mother (family pensioner) having annual income is Rs.6,00,457/- and Rs.6,53,196/- respectively.

In this connection, it is submitted that the Officer has already submitted his property statement of the financial year 2017-19 (2017-18 & 2018-19) online against case id- P00001862020( old case id-772) and same has been processed before Hon'ble Mr. Siddhartha Varma, Administrative Judge, Gorakhpur for His Lordship's kind perusal and orders?

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements for the financial year 2019-21 (2019-20 & 2020-21) vide online dated 09.12.2021. As such, there is no delay in submission of property statement.

May, therefore, if approved, property statements for the financial years 2019-21 (2019-20 & 2020-21) of Sri Amit Kumar, Additional Civil Judge (Sr.Div.)/ Additional Chief Judicial Magistrate, Gorakhpur be laid before Hon'ble Mr. Justice Siddhartha Varma, Administrative Judge, Gorakhpur for His Lordship's kind perusal and orders?
