May kindly see the property statement received online from Sri Tripurari Mishra, Spl. J. (SC/ST, Pev.of Atroci Act), Rai Bareli, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2013-2015 (2013-14 & 2014-15) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2013-2015 (2013-14 & 2014-15) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2013-2015 (2013-14 & 2014-15), the Gross income from salary is Rs.16,28,039/- and total deductions/savings/investment against GIS, CPF, PPF, FD, Insurances and Income Tax is Rs.5,74,302/- and the balance of his savings bank account(s) is also increased by Rs.20,146/- in this financial year from previous year's balance, total of which is Rs.5,94,448/-. Thus, a sum of Rs.10,33,591/- was therefore available with him to meet out the household expenditure of his family consisting three members of the financial year 2013-2015 (2013-14 & 2014-15).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2012-2013 offline and the same has been seen by Hon'ble Mr. Justice Ramesh Sinha, the then Administrative Judge, Gorakhpur Judgeship, in the misc. file of the officer with the direction "Officer concerned is directed to be careful in future ensuring that the property statement is submitted within prescribed time." The order of Hon'ble Court was communicated to the officer vide Court's letter No. 5940/IV-3567/Admin(A) dated. 16.04.2016.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2013-2015 (2013-14 & 2014-15) in its next financial year i.e., 2015-16 upto March 2016. He has submitted movable and immovable property statements of the financial year 2013-2015 (2013-14 & 2014-15) vide online dated 15.12.2021. As such, there is delay in submitting aforesaid property statements from the part of the officer. In this regard, the officer stated in the remark column, that "******due to bona-fide mistake, I could not submit it in due time. I highly apologize for not submitting the same with due time . I humbly requested to excuse me for the same and undertakes that such dealy will not occur in future."

May, therefore, if approved, property statements for the financial year 2013-2015 (2013-14 & 2014-15) of Sri Tripurari Mishra, Spl. J. (SC/ST, Pev.of Atroci Act), Rai Bareli, be laid before Hon'ble Mr. Justice Samit Gopal, Administrative Judge, Rai Bareli Judgeship for His Lordship's kind perusal and orders?
