May kindly see the property statement online received from Sri Anil Kumar Verma-I, District & Sessions Judge, Auraiya regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2018-19 & 2019-20, Total income is Rs.52,87,962/- (Gross income from salary (including arrears & allowances) is Rs.52,30,962/- and sold amount of Car is Rs.57,000/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against CPF, GIS, Income Tax, PPF a/c and Car loan are Rs.20,55,139/-. Thus, a sum of Rs.32,32,823/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years and the balance of his savings bank account(s) is also reduced for Rs.1,73,895/- this financial year from previous year's balance.

It is pertinent to mention here that his wife is Medical consultant having annual income of Rs.4,69,652/- and Rs.4,90,470/- in the financial years 2018-19 & 2019-20 respectively.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial year 2015-16 which has already been seen by Hon'ble Ms. Justice Naheed Ara Moonis, the then Administrative Judge, Etawah in the misc file of the officer and property statement of the financial year 2016-18 has been processed on e-service ID no.4160.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements for the financial years 2018-19 & 2019-20 firstly vide online February,2022. As such, there is delay in submitting the same from the part of the officer for which officer has stated that "Due to pandemic disease unable to furnishing property statement" mentioned in remark column of movable property statement proforma.

May, therefore, if approved, property statements for the financial year 2018-19 & 2019-20 of Sri Anil Kumar Verma-I, District & Sessions Judge, Auraiya be laid before Hon'ble Mrs. Justice Sadhna Rani (Thakur), Administrative Judge, Auraiya Judgeship for Her Lordship's kind perusal and orders?
