In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2011-13 (2011-12 & 2012-13) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2011-13 (2011-12 & 2012-13), Total income from salary is Rs.13,55,455/- and total deductions/ repayment/ savings/ investment against CPF, GIS, Income tax, Insurances, NSC, Car Loan EMI and the balance of his savings bank account(s) is enhanced by Rs.32,079/- this financial year from previous year's balance, total of which is Rs.5,31,892/-. Thus, a sum of Rs.8,23,563/- was available with him to meet out the household expenditure of his family consisting of Four members in both of the financial years.

In this connection, it is submitted that the Officer has already submitted his property statements of the financial year 2009-11 offline and same has been approved with the order "The officer is advised to submit his property statement in time" by the Hon'ble Mr. Justice Mahendra Dayal, the then, Administrative Judge, Kannauj.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2011-13 (2011-12 & 2012-13) in its next financial year i.e., 2013-14 upto March 2014. He has submitted movable and immovable property statements of the financial years 2011-13 (2011-12 & 2012-13) vide online dated 11.12.2021. As such, there is delay in submitting the same. In this regard, officer has stated that due to unavoidable circumstancesnot, he was failed to submit property statements on time, for which he requested to kindly condoned the delay.

May, therefore, if approved, property statements for the financial years 2011-13 (2011-12 & 2012-13) of Sri Surendra Singh-III, Additional District & Sessions Judge, Saharanpur be laid before Hon'ble Mr. Justice Rajiv Gupta, Administrative Judge, Saharanpur Judgeship for His Lordship's kind perusal and orders?
