May kindly see the property statement online received from Sri Arun Kumar Yadava, Civil Judge (Senior Div.), Gorakhpur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2017-19 (2017-18 & 2018-19) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2017-19 (2017-18 & 2018-19) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2017-19 (2017-18 & 2018-19), Gross income ( Salary is Rs. 23,29,064/-, allowances is Rs.67,600/- & maturity of NSC is Rs.12,895) is Rs.24,09,559/- and total deductions/savings/ investment against NPS, GIS, PPF, Income Tax, Insurances, lend from father-in-law, Car loan EMI, FD and the balance of his savings bank account(s) is also enhanced by Rs.2,60,801/- in this financial year from previous year's balance, total of which is Rs.11,49,184/-. Thus, a sum of Rs.12,60,375/- was therefore available with him to meet out the household expenditure of his family consisting three members in the both of the financial year.

In this connection, it is submitted that the Officer had already submitted his property statement of the financial year 2015-17 (2015-16 & 2016-17), which has been seen by Hon'ble Ms Justice Naheed Ara Moonis, the then, Administrative Judge, Sultanpur in the Misc. file of the Officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2017-19 (2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements of the financial year 2017-19 (2017-18 & 2018-19) vide online dated 07.12.2021. As such, there is delay in submitting the same. In this regard, officer most humbly tender an unconditional apology for delay in submission for property statements due to Covid-19 pandemic situation and other exigencies that such delay will not occur in future.

May, therefore, if approved, property statements for the financial years 2017-19 (2017-18 & 2018-19) of Sri Arun Kumar Yadava, Civil Judge (Senior Div.), Gorakhpur be laid before Hon'ble Mr. Justice Siddhartha Varma, Administrative Judge, Gorakhpur for His Lordship's kind perusal and orders?
