May kindly see the property statement received from Sri Prakash Chandra Shukla, Additional District & Sessions Judge, Bijnor regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2015-17 (2015-16 & 2016-17) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2015-17 (2015-16 & 2016-17) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

In the financial year 2015-17 (2015-16 & 2016-17), Gross income from salary and other sources is Rs.24,44,019/- (income from salary including allowances and S.B. Interests Rs.21,89,053/- and income from maturity amount of RD & FD Rs.2,54,966/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against NPS, GIS, Income Tax, LIC, PPF and RD, total of which is Rs.8,16,089/-. Thus, a sum of Rs.16,27,930/- was therefore available with him to meet out the household expenditure of his family consisting of four members in both the financial years. And the balance of his savings bank account(s) is reduced for Rs.2,93,167/- this financial year from previous year's balance.

In this connection, it is submitted that the officer has already submitted his property statement upto financial year 2014-15 which had already been seen by Hon'ble Mr. Justice Sudhir Agarwal, the then Administrative Judge, Gorakhpur in Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2015-17 (2015-16 & 2016-17) in its next financial year i.e., 2017-18 upto March 2018. He has submitted movable and immovable property statements of the financial years 2015-17 (2015-16 & 2016-17) vide online dated 08.12.2021. As such, there is delay in submitting the same from the part of the officer. In this regard, officer has stated that due to certain unavoidable circumstances he could not submit property statements in due time. He further explained that his father became ill and was hospitalized in November 2016, he was again transferred in april 2018, his father got heart attack in july, his aunt became ill and after three months she died in November 2018, sudden wounds cropped up in his both legs, which healed till April 2019 and the covid-19 pandemic affected several kins, relatives & friends, Therefore due to abovementioned reasons he could not submit the same in time.

May, therefore, if approved, property statements of the financial year 2015-17 (2015-16 & 2016-17) of Sri Prakash Chandra Shukla, Additional District & Sessions Judge, Bijnor be laid before Hon'ble Mr. Justice Vivek Varma, Administrative Judge, Bijnor Judgeship for His Lordship's kind perusal and orders?
