May kindly see the property statement received online from Sri Tripurari Mishra, Spl. J. (SC/ST, Pev.of Atroci Act), Rai Bareli, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2017-2019 (2017-18 & 2018-19) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2017-2019 (2017-18 & 2018-19) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2017-2019 (2017-18 & 2018-19), the Gross income from salary is Rs.29,21,571/- and total deductions/savings/investment against GIS,NPS, PPF, Insurances, Car Loan repayments and Income Tax is Rs.12,19,133/-. Thus, a sum of Rs.17,02,438/- was therefore available with him to meet out the household expenditure of his family consisting four members of the financial year 2017-2019 (2017-18 & 2018-19) and the balance of his savings bank account(s) is also decreased by Rs.1,23,489/- in this financial year from previous year's balance.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2015-2017 (2015-16 & 2016-17) online against Case Id : P00020512021 (Old Case Id : 4178) and the same has been processed before Hon'ble Mr. Justice Samit Gopal, Administrative Judge, Rai Bareli Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2017-2019 (2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements of the financial year 2017-2019 (2017-18 & 2018-19) vide online dated 15.12.2021. As such, there is delay in submitting aforesaid property statements from the part of the officer. In this regard, the officer stated in the remark column, that "******** due to bona-fide mistake, I could not submit it in due time. I highly apologize for not submitting the same with due time . I humbly requested to excuse me for the same and undertakes that such delay will not occur in future."

May, therefore, if approved, property statements for the financial year 2017-2019 (2017-18 & 2018-19) of Sri Tripurari Mishra, Spl. J. (SC/ST, Pev.of Atroci Act), Rai Bareli, be laid before Hon'ble Mr. Justice Samit Gopal, Administrative Judge, Rai Bareli Judgeship for His Lordship's kind perusal and orders?
