May kindly see the property statement online received from Sri Manoj Kumar Siddhu, Additional District and Sessions Judge, Aligarh regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2018-20 (2018-19 & 2019-20), Gross income from salary & allowances including arrears is Rs.43,14,557/- and total deductions/savings/ investment against NPS, GIS, Income Tax, Repayment of personal loan, Saving U/S-80c, NSC, Insurance Policy and the balance of his savings account is also increased for Rs.1,24,669/- this financial year from previous year balance, total of which is Rs.22,77,631/-. Thus a sum of Rs.20,36,926/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial years 2018-20 (2018-19 & 2019-20).

It is pertinent to mention here that wife of the officer Smt. Garima Singh is also in U.P. Judicial Service.

In this connection, it is submitted that the Officer has already submitted his property statement upto the financial year 2017-18 Offline and same has been processed before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Aligarh for His Lordship's kind perusal and orders .

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial year 2018-20 (2018-19 & 2019-20) firstly vide online dated 07.12.2021. As such, there is delay in submitting the same. In this regard, officer has not given any reason.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Manoj Kumar Siddhu, Additional District and Sessions Judge, Aligarh be laid before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Aligarh for His Lordship's kind perusal and orders?
