May kindly see the property statement online received from Sri Kuwar Rohit Anand, Civil Judge (Junior Division), Raebareli regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2018-20 (2018-19 & 2019-20), Total income from salary is Rs.15,30,561/- and total deductions/ repayment/ savings/ investment against NPS, GIS, Income Tax, Insurance policies, repayment of car loan and the balance of his savings bank account(s) is enhanced by Rs.3,31,003/- this financial year from previous year's balance, total of which is Rs.11,21,574/-. Thus, a sum of Rs.4,08,987/- was available with him to meet out the household expenditure of his family consisting of two members in both of the financial years.

In this connection, it is submitted that the officer has already submitted his property statement at the time of joining, which has already been seen online by Hon'ble Mr. Justice Rajnish Kumar, Administrative Judge, Deoria Judgeship on old case Id no-254.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-20 (2018-19 & 2019-20) vide online dated 09.12.2021. As, there is delay in submitting aforesaid property statements from the part of the officer. In this regard, officer has stated that the same could not be submitted due to the nationwide lockdown and closure of District Courts because of the Covid-19 Pandemic. So, the officer has requested to pardon him for late forwarding this statement and also requested to bring this information to the knowledge of the Hon'ble High Court.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Kuwar Rohit Anand, Civil Judge (Junior Division), Raebareli be laid before Hon'ble Mr. Justice Samit Gopal, Administrative Judge, Raebareli Judgeship for His Lordship's kind perusal and orders?
