May kindly see the property statement online received from Smt. Sudha Singh, Chief Judicial Magistrate, Unnao regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial years 2017-19 (2017-18 & 2018-19) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2017-19 (2017-18 & 2018-19) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

(1) In the financial years 2017-19 (2017-18 & 2018-19), Gross income from salary is Rs.23,82,863/- and total deductions/savings/ investment against NPS, GIS, Income Tax, PPF, Mutual fund and Insurances is Rs.7,67,461/-. Thus a sum of 16,15,402/- was therefore available with her to meet out the household expenditure of her family consisting of four members in the financial year 2017-19 (2017-18 & 2018-19) and the balance of her savings account is also decreased for Rs.46,252/- this financial year from previous year balance.

It is pertinent mention here that Officer husband (Assistant District Prosecution Officers) having annual income Rs.9,00,000/-.

In this connection, it is submitted that the Officer has already submitted her property statement for the financial year 2015-17(2015-16 & 2016-17) against Misc. file of the Officer and same has been processed before Hon'ble Mr. Justice Irshad Ali, Administrative Judge, Unnao for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2017-19 (2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto March 2020. She has submitted movable and immovable property statements of the financial year 2017-19 (2017-18 & 2018-19) vide online dated 10.12.2021. As such, there is delay in submitting the same. In this regard, officer stated that due to Corona, she was down and apart from that Pre and post symptoms of Corona on the whole family, that's the reason she could not submitted in time, she apologize for this delay.

May, therefore, if approved, property statements for the financial years 2017-19 (2017-18 & 2018-19) of Smt. Sudha Singh, Chief Judicial Magistrate, Unnao be laid before Hon'ble Mr. Justice Rajiv Gupta, Administrative Judge, Unnao for His Lordship's kind perusal and orders?
