May kindly see the property statement online received from Sri Amit Singh-I, Additional District & Sessions Judge, Barabanki regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2012-14 (2012-13 & 2013-14) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2012-14 (2012-13 & 2013-14) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2012-14 (2012-13 & 2013-14), Gross income from salary Rs. 18,40,126 and total deductions/savings/ investment against NPS, GIS, PPF, Income Tax and the balance of his savings bank account(s) is also enhanced by Rs.7,81,767/- in this financial year from previous year's balance, total of which is Rs.13,00,698/-. Thus, a sum of Rs.5,39,428/- was therefore available with him to meet out the household expenditure of his family consisting four members in the both of the financial year.

It is pertinent to mention here that Officer wife (Lecturer in Government Girls inter college) having annual income Rs.3,84,000/- and Rs.4,00,300/- in the respective financial years.

In this connection, it is submitted that the Officer has already submitted his property statement at the time of Joining into U.P. Judicial Service alongwith financial years 2006-08 (2006-07 & 2007-08), 2008-10 (2008-09 & 2009-10) & 2010-12 (2010-11 & 2011-12) misc. file and same has been moved before Hon'ble Mr. Justice Vivek Varma, Administrative Judge, Barabanki for His Lordship's kind perusal and orders..

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2012-14 (2012-13 & 2013-14) in its next financial year i.e., 2014-15 upto March 2015. He has submitted movable and immovable property statements of the financial year 2012-14 (2012-13 & 2013-14) vide online dated 10.12.2021. As such, there is delay in submitting the same. In this regard, officer has not given any reason.

May, therefore, if approved, property statements for the financial years 2012-14 (2012-13 & 2013-14) of Sri Amit Singh-I, Additional District & Sessions Judge, Barabanki be laid before Hon'ble Mr. Justice Vivek Varma, Administrative Judge, Barabanki for His Lordship's kind perusal and orders?
