May kindly see the property statement online received from Sri Vijay Kumar Verma-II, Civil Judge (Senior Div.), Kushi Nagar at Padrauna regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2013-15 (2013-14 & 2014-15) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2013-15 (2013-14 & 2014-15) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years2013-15 (2013-14 & 2014-15), Total Gross income from salary is Rs 12,06,419/- and total deductions/ repayment/ savings/ investment against GIS,INCOME TAX,NPS,PPF and the balance of his savings bank account(s) is enhanced by Rs.7,55,064/- this financial year from previous year's balance, total of which is Rs.11,12,581/-. Thus, a sum of Rs.93,838/- was available with him to meet out the household expenditure of his family consisting of three members in both of the financial years.

It is pertinent to mention here that his wife is MBBS practicing doctor.

In this connection, it is submitted that the officer has already submitted his property statements at the time of entering into judicial service which are currently processed online & separate notes has been made on Case Id :P00021012021 (Old Case Id :4228) and has been moved before Hon'ble Mr. Justice Deepak Verma, Administrative Judge, Kushi Nagar for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2013-15 (2013-14 & 2014-15) in its next financial year i.e., 2015-16 upto March 2016. He has submitted movable and immovable property statements of the financial years 2013-15 (2013-14 & 2014-15) vide online dated 10.12.2021. However objection was raised which was removed and officer reuploaded the same on 22/08/2022. As, there is delay in submitting aforesaid property statements from the part of the officer. In this regard, officer has stated that he could not submit the property statement in time due to his father, mother and wife were suffering from diseases. also, he lost his mother during corona pandemic. moreover he was posted in small districts which kept the officer overburdened with the work due to pendency, the officer prays before the Hon'ble High court for the delay be condoned.
