In this connection, it is submitted that the officer has already submitted his property statements at the time of entering into judicial service and financial year 2013-15, 2015-17 which are currently processed online & separate notes has been made on Case Id: P00021012021 (Old Case Id: 4228), Case Id: P00021042021 (Old Case Id: 4231) and Case Id: P00021092021 (Old Case Id: 4236) and has been moved before Hon'ble Mr. Justice Mohd Faiz Alam Khan, Administrative Judge, Kushi Nagar for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2017-19 (2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements of the financial years 2017-19 (2017-18 & 2018-19) vide online dated 10.12.2021. However objection was raised which was removed and officer reuploaded the same on 22/08/2022. As, there is delay in submitting aforesaid property statements from the part of the officer.
