May kindly see the property statement received online from Smt. Mona Singh, Addl. Civil Judge (Sr.Div.)/ACJM, Lakhimpur Kheri, regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2016-2018 (2016-17 & 2017-18) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2016-2018 (2016-17 & 2017-18) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial year 2016-2018 (2016-17 & 2017-18), the Gross income from salary is Rs.9,88,386/- and total deductions/ repayment/ savings/ investment against GIS, PPF, Car Loan repayments and Income Tax are Rs.3,80,210/- and the balance of her savings bank account is also increased by Rs.31,244/- in this financial year from previous year's balance, total of which is Rs.4,11,454/-. Thus, a sum of Rs.5,76,932/- was therefore available with herself in the financial year 2016-2018 (2016-17 & 2017-18).

In this connection, it is submitted that the officer has already submitted her property statement at the time of joining in U.P. Judicial Service online against Case Id : P00018022021 (Old Case Id : 3922) and the same has been processed by submitting it before Hon'ble Mr. Justice Abdul Moin, Administrative Judge, Lakhimpur Kheri for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2016-2018 (2016-17 & 2017-18) in its next financial year i.e., 2018-19 upto March 2019. She has firstly submitted movable and immovable property statements of the financial year 2016-2018 (2016-17 & 2017-18) vide online dated 09.12.2021. As such, there is delay in submitting the same for which the officer has stated that (in her verbatim) "I was unable to submit the property statement on time due to health issues, lot of work and due to lack of technical knowledge about use of e-service portal. I apologise for the late submission", in the remark column.

May, therefore, if approved, property statements for the financial year 2016-2018 (2016-17 & 2017-18) of Smt. Mona Singh, Addl. Civil Judge (Sr.Div.)/ACJM, Lakhimpur Kheri, be laid before Hon'ble Mr. Justice Abdul Moin, Administrative Judge, Lakhimpur Kheri Judgeship for His Lordship's kind perusal and orders?
