May kindly see the property statement online received from Smt. Pratibha Saxena-II, Additional District & Sessions Judge, Bareilly regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial years 2012-14 (2012-13 & 2013-14) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2012-14 (2012-13 & 2013-14) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial years 2012-14 (2012-13 & 2013-14), her gross income from salary and E.L. Encashment and arrears are Rs.20,86,545/- and total deductions/Savings/investments against NPS, GIS, Income Tax, Repayment of personal loan & car loan alongwith down-payment, NSC and Insurances are Rs.13,71,149/-. The balance of Rs.35,564/- has decreased from her saving bank A/c's against the balance of the previous year. Thus a sum of Rs.7,50,960/- (Rs.7,15,396/- from salary and Rs.35,564/- from saving bank account withdrawal) was therefore available with her to meet out the household expenditure of her family consisting three members in the financial years 2012-14 (2012-13 & 2013-14).

In this connection, it is submitted that the Officer has already submitted her property statement for the financial years 2010-12 (2010-11 & 2011-12) online against case id- P00018062021 (old case id-3926) and same has been processed before Hon'ble Mr. Justice Ajeet Kumar, Administrative Judge, Bareilly Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2012-14 (2012-13 & 2013-14) in its next financial year i.e., 2014-15 upto March 2015. She had submitted movable and immovable property statements for the financial years 2012-14 (2012-13 & 2013-14) vide online dated 09.12.2021 on eServicesJo portal. As such, there is delay in submitting the same. In this regard, officer verbatim: "due to serious illness of the father, the serious illness of the mother-in-law and father-in-law suffering from cancer and thereafter their death and also due to the discharge of family responsibilities and the arrangement of judicial work, the applicant could not submitted her property statement to the Hon'ble High Court on time. Although during this period, whatever movable and immovable property was purchased by the applicant, it was purchased after obtaining permission as per rules from the Hon'ble High Court and the information about the same had already been sent to the Hon'ble High Court at the prescribed time period. The applicant apologizes for the delay and assures to submit her property statements on time in future."

May, therefore, if approved, property statements for the financial years 2012-14 (2012-13 & 2013-14) of Smt. Pratibha Saxena-II, Additional District & Sessions Judge, Bareilly be laid before Hon'ble Mr. Justice Ajit Kumar, Administrative Judge, Bareilly Judgeship for His Lordship's kind perusal and orders?
