May kindly see the property statement received online from Sri Vikas Kumar-I, District & Sessions Judge, Chitrakoot, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2014-2016 (2014-15 & 2015-16) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2014-2016 (2014-15 & 2015-16) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2014-2016 (2014-15 & 2015-16), the Gross income is Rs.34,62,046/- (Rs.33,47,322/- from salary and Rs.1,14,724/- from Bank Interest) and total deductions/savings/investment against GIS, NPS, PPF, Insurances, Sukanya Samridhhi Account, NSC and Income Tax is Rs.11,76,208/-. Thus, a sum of Rs.22,85,838/- was therefore available with him to meet out the household expenditure of his family consisting five members of the financial year 2014-2016 (2014-15 & 2015-16) and the balance of his savings bank account(s) is also increased by Rs.3,38,694/- in this financial year from previous year's balance.

It is pertinent to mention here that his wife, Smt. Mona has monthly income of Rs.20,000/- through profession as Dietician (as mentioned by the officer).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2012-13 & 2013-14 offline and the same has been seen by Hon'ble Mr. Justice S. N. Shukla, the then Administrative Judge, Budaun Judgeship, in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2014-2016 (2014-15 & 2015-16) in its next financial year i.e., 2016-17 upto March 2017. He has firstly submitted movable and immovable property statements of the financial year 2014-2016 (2014-15 & 2015-16) vide online dated 07.12.2021. As such, there is delay in submitting the same from the part of the officer, for which the officer has stated that "*due to heavy load of work and stress, there was delay in filing statement related property in due time*", in the remark column.

May, therefore, if approved, property statements for the financial year 2014-2016 (2014-15 & 2015-16) of Sri Vikas Kumar-I, District & Sessions Judge, Chitrakoot, be laid before Hon'ble Mr. Justice Syed Qamar Hasan Rizvi, Administrative Judge, Chitrakoot Judgeship for His Lordship's kind perusal and orders?
