May kindly see the property statement online received from Sri Devashish, Additional District & Sessions Judge, Bareilly regarding submission of statement for movable and immovable properties acquired/held by him or any member of his family of the financial years 2017-19 (2017-18 & 2018-19) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2017-19 (2017-18 & 2018-19) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2017-19 (2017-18 & 2018-19), his gross income from salary is Rs.22,94,683/and total deductions/Savings/investments against, NPS, GIS, Income Tax, PPF, loan-repayment, Sukanya Samriddhi Yojna and Insurances are Rs.14,73,166/-. The balance of Rs.77,630/- has decreased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.8,99,147/-(Rs.8,21,517/- from salary and Rs.77,630/- from saving bank account withdrawal) was therefore available with him to meet out the household expenditure of his family consisting four members in the financial years 2017-19 (2017-18 & 2018-19).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2015-17 (2015-16 & 2016-17) online against case id-P00021702021 (old case-id: 4297) and same has been processed before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Bareilly Judgeship for His Lordship's kind perusal and orders .

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2017-19 (2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements for the financial years 2017-19 (2017-18 & 2018-19) vide online dated 13.12.2021. As such, there is delay in submitting the same. In this regard officer verbatim: "It is most humbly submitted that due to work load & some health issues of my mother I could not submit the statement in time for which I seek unconditional apology" mentioned in the remark column.

May, therefore, if approved, property statements for the financial years 2017-19 (2017-18 & 2018-19) of Sri Devashish, Additional District & Sessions Judge, Bareilly be laid before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Bareilly Judgeship for His Lordship's kind perusal and orders?
