

## **Registrar(J)(Budget)**

May kindly see the property statement received online from Sri Vikas Kumar-I, District & Sessions Judge, Chitrakoot, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2016-2018 (2016-17 & 2017-18) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2016-2018 (2016-17 & 2017-18) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

**In the financial year 2016-2018 (2016-17 & 2017-18)**, the Gross income is Rs.38,61,613/- (Rs.36,72,802/- from salary & Rs.1,88,811/- from Bank Interest) and total deductions/savings/investment against GIS, NPS, PPF, Insurances, Sukanya Samridhhi Account and Income Tax is Rs.15,22,495/- and the balance of his savings bank account(s) from salaried income is also increased by Rs.17,49,846/- in this financial year from previous year's balance, total of which is Rs.32,72,341/-. Thus, a sum of Rs.5,89,272/- was therefore available with him to meet out the household expenditure of his family consisting five members of the financial year 2016-2018 (2016-17 & 2017-18).

It is pertinent to mention here that his wife, Smt. Mona have monthly income of Rs.20,000/- through profession as Dietician (as mentioned by the officer).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2014-2016 (2014-15 & 2015-16) online against Case Id : P00021772021 (Old Case Id : 4304) and the same has been processed before Hon'ble Mr. Justice Syed Qamar Hasan Rizvi, Administrative Judge, Chitrakoot Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2016-2018 (2016-17 & 2017-18) in its next financial year i.e., 2018-19 upto March 2019. He has firstly submitted movable and immovable property statements of the financial year 2016-2018 (2016-17 & 2017-18) vide online dated 07.12.2021. As such, there is delay in submitting the same from the part of officer, for which the officer has stated that "*due to illness of my father, I was busy and due to heavy load of work. I could not file property statement in due time*", in the remark column.

May, therefore, if approved, property statements for the financial year 2016-2018 (2016-17 & 2017-18) of Sri Vikas Kumar-I, District & Sessions Judge, Chitrakoot, be laid before Hon'ble Mr. Justice Syed Qamar Hasan Rizvi, Administrative Judge, Chitrakoot Judgeship for His Lordship's kind perusal and orders?
