LR (Nyay Vibhag), Government of U.P., Lucknow regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2011-13 (2011-12 & 2012-13) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2011-13 (2011-12 & 2012-13) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2011-13 (2011-12 & 2012-13), Total income from salary is Rs.11,73,758/- and total deductions/ repayment/ savings/ investment against CPF/NPS, GIS, TDS, SIP, PPF, repayment of loan and the balance of his savings bank account(s) is enhanced by Rs.1,12,098/- this financial year from previous year's balance, total of which is Rs.6,59,411/-. Thus, a sum of Rs.5,14,347/- was available with him to meet out the household expenditure of his family consisting of three members in both of the financial years.

It is pertinent to mention here that father of the officer is Retired Director, Chemical Division, Geological Survey of India (GSI) Lucknow and his income about 4,00,000/- (Rs. Four Lakhs) per annum from Pension & Interest on F.Ds. & Post Office Deposits.

In this connection, it is submitted that the officer has already submitted his property statements of the financial years 2009-11, which has already been processed online before Hon'ble Mr. Justice Mahesh Chandra Tripathi, Administrative Judge, Lucknow Judgeship on old case id no.4312.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2011-13 (2011-12 & 2012-13) in its next financial year i.e., 2013-14 upto March 2014. He has submitted movable and immovable property statements of the financial years 2011-13 (2011-12 & 2012-13) vide online dated 9.12.2021. As, there is delay in submitting the aforesaid property statements from the part of the officer. In this regard, officer has not given any reason for delay.

May, therefore, if approved, property statements for the financial years 2011-13 (2011-12 & 2012-13) of Sri Indra Jeet Singh-I, Spl. Sec. & Addl.
