May kindly see the property statement online received from Sri. Ravindra Prasad Gupta, Cheif Legal Advisor, Noida, Gautambuddha Nagar regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-20(2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20(2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2018-20(2018-19 & 2019-20), Gross income from salary is Rs.36,98,397/- and total deductions/ repayment/ savings/ investment against GPF, GIS, PPF, LIC, SIP, SBI Life Insurance, Income Tax, Home Loan EMI and the balance of his savings bank account(s) is enhanced by Rs.3,50,326/- this financial year from previous year's balance, total of which is Rs.27,68,426/-. Thus, a sum of Rs.9,29,971/- was available with him to meet out the household expenditure of his family consisting of three members in both of the financial years.

It is pertinent to mention here that his wife has legal profession having annual income Rs.10 Lakh & Rs.12.5 Lakh for both the years respectively.

In this connection, it is submitted that the Officer has already submitted his property statements of the 2016-18 offline and same has been approved by the Hon'ble Mr. Justice Shashi Kant Gupta, the then, Administrative Judge, Ghaziabad Judgeship in Misc. file of the Officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20(2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-20(2018-19 & 2019-20) vide online dated 07.12.2021. As such, there is delay in submitting the same. In this regard Officer has stated that "he could not send the required particulars of property in time because of the limited functioning of the court due to corona pandemic. he sincerely apologize of the delay in this regard".

May, therefore, if approved, property statements for the financial years 2018-20(2018-19 & 2019-20) of Sri. Ravindra Prasad Gupta, Cheif Legal Advisor, Noida, Gautambuddha Nagar be laid before Hon'ble Mr. Justice Rohit Ranjan Agarwal, Administrative Judge, Gautambuddha Nagar for His Lordship's kind perusal and orders?
