May kindly see the property statement online received from Sri Ram Avtar Yadav, Additional District and Sessions Judge, Bijnor regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2018-20 (2018-19 & 2019-20), Gross income from salary is Rs.42,14,087/- and total deductions/savings/ investment against GPF, GIS, PPF, Income Tax, Repayment of loan, Sukanya Samridhi Yojna and Insurances is Rs.17,60,957/-. Thus a sum of Rs.24,34,688/-(Rs.17,60,957 from salary and Rs.6,57,195/- from saving account) was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial years 2018-20 (2018-19 & 2019-20) and the balance of his savings account is also decreased for Rs.6,73,731/-this financial year from previous year balance.

In this connection, it is submitted that the Officer has already submitted his property statement up to the financial year 2017-18 Offline, which had already been seen by Hon'ble Mr. Justice Saurabh Lavania, the then Administrative Judge, Bijnor in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial year 2018-20 (2018-19 & 2019-20) vide online dated 10.12.2021. As such, there is delay in submitting the same. In this regard, officer stated that: he could not be submitted in due time due to Covid-19 pandemic and oversight, the same is being submitted now. Delay in submitting the property statement is regretted and officer begs pardon for the delay. On that time, He was also COVID positive.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Ram Avtar Yadav, Additional District and Sessions Judge, Bijnor be laid before Hon'ble Mr. Justice Vivek Varma, Administrative Judge, Bijnor for His Lordship's kind perusal and orders?
