May kindly see the property statements received online from Sri Chandra Pal-II, Special Judge (E. C. Act), Prayagraj regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2018-20 (2018-19 & 2019-20), Total income from salary and other sources is Rs.59,29,119/- (income from salary Rs.55,33,119/- and income from house rent Rs.3,96,000/-) and total deductions/ repayment/ savings/ investment against GIS, GPF, Income Tax, PPF, Insurances, repayment of home loan, paid to sky high infra projects for flat, total of which is Rs.33,70,796/-. Thus, a sum of Rs.25,58,323/- was available with him to meet out the household expenditure of his family consisting of four members in both of the financial years and the balance of his savings bank account(s) is decreased by Rs.28,590/- this financial year from previous year's balance.

In this connection, it is submitted that the officer has already submitted his property statements of the financial years 2016-18 which is already seen by Hon'ble Mr. Justice Manoj Mishra, the then Administrative Judge, Hapur in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-20 (2018-19 & 2019-20) vide online dated 08.12.2021. As, there is delay in submitting aforesaid property statements from the part of the officer. In this regard, the officer has stated that he could not submit the property statement in time, due to Corona pandemic and his transfer from Hapur to Allahabad.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Chandra Pal-II, Special Judge (E.C. Act), Prayagraj be laid before Hon'ble Mrs. Justice Sangeeta Chandra, Administrative Judge, Allahabad Judgeship for Her Lordship's kind perusal and orders?
