May kindly see the property statement online received from Sri Kush Kumar, Spl. Sec.& Addl. LR (Nyay Vibhag), Government of U.P., Lucknow regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2019-21 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2019-21 (2019-20 & 2020-21), Gross income is Rs.32,97,908/- and total deductions/ repayment/ savings/ investment against NPS, GIS, Income Tax, PPF, Insurances, Sukanya Samridhi Yojna, repayment of home loan and the balance of his savings bank account(s) is enhanced by Rs.10,33,000/- this financial year from previous year's balance, total of which is Rs.28,87,080/-. Thus, a sum of Rs.4,10,828/- was available with him to meet out the household expenditure of his family consisting of four members in both of the financial years.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial years 2017-19, which has already been processed online before Hon'ble Mr. Justice Mahesh Chandra Tripathi, Administrative Judge, Lucknow on old case Id no-2617.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements of the financial years 2019-21 (2019-20 & 2020-21) vide online dated 30.03.2022. As such, there is no delay in submitting aforesaid property statements.

May, therefore, if approved, property statements for the financial years 2019-21 (2019-20 & 2020-21) of Sri Kush Kumar, Spl. Sec.& Addl. LR (Nyay Vibhag), Government of U.P., Lucknow be laid before Hon'ble Mr. Justice Mahesh Chandra Tripathi, Administrative Judge, Lucknow Judgeship for His Lordship's kind perusal and orders?
