May kindly see the property statement received from Sri Suyash Prakash Srivastava, Special Judge (SC/ST, Pev.of Atroci Act), Budaun, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2008-10 (2008-09 & 2009-10) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2008-10 (2008-09 & 2009-10) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

In the financial years 2008-10 (2008-09 & 2009-10), Gross salary is Rs.7,60,136/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GPF, GIS, Income Tax, PPF, Insurances and the balance of his savings bank account(s) is enhanced for Rs.72,024/- this financial year from previous year's balance, total of which is Rs.3,33,868/-. Thus, a sum of Rs.4,26,268/- was therefore available with him to meet out the household expenditure of his family consisting of three members in both the financial years.

It is pertinent to mention here that officer's wife Smt. Madhavi Srivastava is a Research Scholar, having annual income Rs.60,000/-.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial years 2007-08, which had already been seen by Hon'ble Mr. Justice Dilip Gupta, the then Administrative Judge, Mathura in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2008-10 (2008-09 & 2009-10) in its next financial year i.e., 2010-11 upto March 2011. He has submitted movable and immovable property statements of the financial years 2008-10 (2008-09 & 2009-10) firstly vide online dated 10.12.2021. As such, there is delay in submitting the same from the part of the officer, for which he has not mentioned any reason for delay submission.

May, therefore, if approved, property statements of the financial years 2008-10 (2008-09 & 2009-10) of Sri Suyash Prakash Srivastava, Special Judge (SC/ST, Pev.of Atroci Act), Budaun, be laid before Hon'ble Mr. Justice Saurabh Lavania, Administrative Judge, Budaun for His Lordship's kind perusal and orders?
