May kindly see the online property statements received from Sri Devendra Pratap Singh, Additional Chief Judicial Magistrate, Hardoi regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2016-17 & 2017-18 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2016-17 & 2017-18 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2016-17 (i.e., 12.01.2017 to 31.03.2017) & 2017-18, Total Gross salary is Rs.9,33,527/- and total deductions/ repayment/ savings/ investment against GIS, Income Tax, PPF, LIC policy, PLI and the balance of his savings bank account(s) has been enhanced for Rs.42,311/- this financial year from previous year's balance, total of which is Rs.2,71,433/-. Thus, a sum of Rs.6,62,094/- was therefore available with him to meet out the household expenditure of himself in both the financial years 2016-17 (i.e., 12.01.2017 to 31.03.2017) & 2017-18 .

In this connection, it is submitted that he has already submitted his property statement at the time of joining which has already been seen by Hon'ble Mr. Justice Manoj Kumar Gupta, the then Administrative Judge, Faizabad in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2016-17 & 2017-18 in its next financial year i.e., 2018-19 upto March,2019. He has submitted movable and immovable property statements for the financial year 2016-18 firstly vide online dated 11.12.2021. As such, there is delay in submitting the same from the part of the officer for which he has stated that *"he has inadvertently submitted the property statement for the financial years 2016-2017 and 2017-2018 with delay. He apologized for late submission and in future, he will submit the statements within time."* mentioned in attachment "APPLICATION".

May, therefore, if approved, property statements for the financial year 2016-17 & 2017-18 of Sri Devendra Pratap Singh, Additional Chief Judicial Magistrate, Hardoi be laid before Hon'ble Mrs. Justice Manju Rani Chauhan, Administrative Judge, Hardoi Judgeship for Her Lordship's kind perusal and orders?
