May kindly see the property statement received from Sri Ashish Kumar Rai, Chief Judicial Magistrate, Basti regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2019-21 (2019-20 & 2020-21) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

In the financial year 2019-21 (2019-20 & 2020-21), Gross income from salary is Rs.26,47,960/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GPF/NPS, GIS, Income Tax, LIC, PPF, Mutual Fund (SIP), SSA and repayment of car loan, total of which is Rs.11,26,541/-. Thus, a sum of Rs.15,21,419/- was therefore available with him to meet out the household expenditure of his family consisting of three members in both the financial years. And the balance of his savings bank account(s) is reduced for Rs.1,25,961/- this financial year from previous year's balance.

It is pertinent to mention here that his wife Smt. Swati Rai, Profession- service (assistant manager, Union Bank Of India), Annual Income in F.Y. 2019-2020 Rs. 593414/- and in F.Y. 2020-2021- Rs.1069611/-

In this connection, it is submitted that the officer has already submitted his property statement upto financial year 2017-19 which had already been processed before Hon'ble Mr. Justice Piyush Agrawal, Administrative Judge, Basti on old case Id no-4004.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements of the financial years 2019-21 (2019-20 & 2020-21) vide online dated 10.12.2021. As such, there is no delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements of the financial year 2019-21 (2019-20 & 2020-21) of Sri Ashish Kumar Rai, Chief Judicial Magistrate, Basti be laid before Hon'ble Mr. Justice Piyush Agrawal, Administrative Judge, Basti Judgeship for His Lordship's kind perusal and orders?
