May kindly see the property statement online received from Sri Abhishek Kumar Srivastav, Additional District and Sessions Judge, Ambedkar Nagar at Akbarpur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2019-21 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2019-21 (2019-20 & 2020-21), Gross income is Rs.41,74,029/-(Including bank interests and allowances) and total deductions/savings/ investment against NPS, GIS, PPF, Income Tax, SIP, RD, Mutual Fund and Insurances is Rs.23,95,986/-. Thus, a sum of Rs.24,30,054/-( Rs.17,78,043 from salary and Rs.6,52,011/- from saving account) was therefore available with him to meet out the household expenditure of his family consisting of three members in the both of the financial year and the balance of his savings account is also decreased for Rs.6,52,011/- this financial year from previous year balance

It is pertinent mention here that Officer wife ( Chief Judicial Magistrate at Ambedkar Nagar U.P.) having annual income Rs.18,11,141/-(2019-20) and Rs.21,44,724/- (2020-21) respectively.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2017-19 (2017-18 & 2018-19) against online case id-P00016752021 (Old Case id-3792) and same has been processed before Hon'ble Mr. Justice Rajendra Kumar-IV, Administrative Judge, Ambedkar Nagar for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements for the financial years 2019-21 (2019-20 & 2020-21) vide online dated 08.12.2021. As such, there is no delay in submission of property-statement.

May, therefore, if approved, property statements for the financial years 2019-21 (2019-20 & 2020-21) of Sri Abhishek Kumar Srivastav, Additional District and Sessions Judge, Ambedkar Nagar at Akbarpur be laid before Hon'ble Mr. Justice Rajendra Kumar-IV, Administrative Judge, Ambedkar Nagar for His Lordship's kind perusal and orders?
