May kindly see the property statement online received from Sri Sandeep Chuadhary, A.D.J. (FTC), Ghaziabad regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2013-15 (2013-14 & 2014-15) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2013-15 (2013-14 & 2014-15) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2013-15 (2013-14 & 2014-15), his gross income from salary is Rs.18,02,236/- and total deductions/Savings/investments against NPS, GIS, Income Tax, Insurances, PPF and Repayment of Car loan are Rs.5,68,167/-. The balance of Rs.12,237/- has increased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.12,34,069/- was therefore available with him to meet out the household expenditure of his family consisting four members in the financial years 2013-15 (2013-14 & 2014-15).

It is pertinent to mention here that officer's wife (Judge Small Causes Court, Ghaziabad) having annual income was Rs.9,10,800/- approximately for the financial years 2013-14 & Rs.8,76,000/- approximately for the financial year 2014-15 respectively.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2011-13 (2011-12 & 2012-13) online against case id-P00023102021 (old case id-4441) and same has been processed before Hon'ble Mr. Justice Saumitra Dayal Singh, Ghaziabad Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2013-15 (2013-14 & 2014-15) in its next financial year i.e., 2015-16 upto March 2016. He has submitted movable and immovable property statements for the financial years 2013-15 (2013-14 & 2014-15) vide online dated 10.12.2021. As such, there is delay submitting the same. In this regard officer verbatim: "It is most humbly submitted that on account of work pressure and owing to over sightedness applicant has failed to submit his Property statement in time for which he tenders unconditional apology and assure the Hon'ble Court that he shall remain punctual in filing Property statement in future "

May, therefore, if approved, property statements for the financial years 2013-15 (2013-14 & 2014-15) of Sri Sandeep Chuadhary, A.D.J. (FTC), Ghaziabad be laid before Hon'ble Mr. Justice Saumitra Dayal Singh, Ghaziabad Judgeship for His Lordship's kind perusal and orders?
