May kindly see the property statements online received from Sushri Neelam Saroj, Addl. Chief Judicial Magistrate, Farrukhabad regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

In the financial years 2018-20 (2018-19 & 2019-20), Gross income is Rs.21,65,181/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income Tax, PPF and the balance of her savings bank account(s) is enhanced for Rs.1,24,387/-, total of which is Rs.8,00,930/-. Thus, a sum of Rs.13,64,251/- was therefore available with her to meet out the household expenditure of herself in both the financial years. It is pertinent to be mention here that her father Mr. R.P. Saroj posted as ADJ, Gonda.

In this connection, it is submitted that the officer has already submitted her property statement of the financial years 2016-18 which has already been processed before Hon'ble Mr. Justice Shekhar Kumar Yadav, Administrative Judge, Farrukhabad on e-service ID no.4448.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. She has submitted movable and immovable property statements for the financial years 2018-20 (2018-19 & 2019-20) vide online dated 11.12.2021. As such, there is delay in submitting the property statement from the part of the officer. In this regard, she stated that it is most respectfully submitted that due to certain unavoidable reasons and due to misplacement of certain bank related documents, the same could not be sent earlier, for which she conveys her sincere apologies and undertakes to adhere to timely submissions of the same in the near future.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sushri Neelam Saroj, Addl. Chief Judicial Magistrate, Farrukhabad be laid before Hon'ble Mr. Justice Shekhar Kumar Yadav, Administrative Judge, Farrukhabad Judgeship for His Lordship's kind perusal and orders?
