May kindly see the property statement received online from Sri Mayuresh Srivastav, Additional Civil Judge (Senior Div.)/ACJM, Agra regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2018-20 (2018-19 & 2019-20), Gross income from salary is Rs.16,46,397/- and total deductions/savings/investment against NPS, GIS, Income Tax, PPF, LIC and the balance of his savings bank account is also enhanced by Rs.2,92,300/- in this financial year from previous year's balance, total of which is Rs.5,79,619/-. Thus, a sum of Rs.10,66,778/- was therefore available with him to meet out the household expenditure of himself in both of the financial years.

In this connection, it is submitted that the Officer has submitted his property statement held at the time of joining into U.P. Judicial Service and the same has been approved online against Case Id : P00005112020 by Hon'ble Mr. Justice Rakesh Srivastava, the then Administrative Judge, Faizabad Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted his movable and immovable property statements for the financial years 2018-20 (2018-19 & 2019-20) vide online dated 08.12.21. As such, there is delay in submitting the same from the part of the officer, for which, he has stated that "he seeks unconditional apology for submitting the property statement after considerable delay. The delay was not intentional. He assures the Hon'ble Court that he will remain vigilant in near future"

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Mayuresh Srivastav, Additional Civil Judge (Senior Div.)/ACJM, Agra be laid before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Agra Judgeship for His Lordship's kind perusal and orders?
