In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

In the financial years 2019-21 (2019-20 & 2020-21), Total income from salary & other sources is Rs.41,39,360/- (income from salary Rs.33,38,824/-, income from encashment of FD Rs.4,56,037/- & income from maturity amount of RD Rs.3,74,499/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income Tax, Insurance policies, mutual fund, PPF and the balance of his savings bank account(s) is enhanced for Rs.4,67,309/- this financial year from previous year's balance, total of which is Rs.16,77,753/-. Thus, a sum of Rs.24,51,607/- was therefore available with him to meet out the household expenditure of his family consisting of four members in both the financial years.

It is pertinent to mention here that wife of the officer Smt. Astha Srivastava is ACJM, UP Judicial Service, having annual income Rs. 14 lac approx.

In this connection, it is submitted that the officer has already submitted his property statement of the financial years 2017-19 which has already been processed before Hon'ble Mr. Justice Ajit Singh Administrative Judge, Maharajganj on old case ID no-3765.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements for the financial years 2019-21 (2019-20 & 2020-21) vide online dated 10.12.2021. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2019-21 (2019-20 & 2020-21) of Sri Saurabh Srivastava-I, Chief Judicial Magistrate, Maharajganj be laid before Hon'ble Mr. Justice Ajit Singh, Administrative Judge, Maharajganj Judgeship for His Lordship's kind perusal and orders?
