May kindly see the property statement received online from Sri Surya Kant Dhar Dubey, Chief Judicial Magistrate, Chitrakoot regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2019-21 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2019-21 (2019-20 & 2020-21), Gross salary is Rs.32,26,019/- and total deductions/savings/investment against GIS, NPS, Income Tax, PPF, LIC, car loan and the balance of his savings bank account is also enhanced by Rs.10,06,387/- in this financial year from previous year's balance, total of which is Rs.22,14,921/-. Thus, a sum of Rs.10,11,098/- was therefore available with him to meet out the household expenditure of his family consisting three members in both of the financial years. It is pertinent to mention here that Officer's wife is working as Dy. S.P. (PPS) in U.P., having annual income of Rs.9,00,000/- from salary, as mentioned by the Officer.

In this connection, it is submitted that the Officer has submitted his property statement upto financial years 2017-19 and the same has been processed online against Case Id : P00006262023 before Hon'ble Mr. Justice Vikram D Chauhan, Administrative Judge, Chitrakoot Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. He has submitted his movable and immovable property statements for the financial years 2019-21 (2019-20 & 2020-21) firstly vide online dated 10.12.2021. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2019-21 (2019-20 & 2020-21) of Sri Surya Kant Dhar Dubey, Chief Judicial Magistrate, Chitrakoot be laid before Hon'ble Mr. Justice Vikram D Chauhan, Administrative Judge, Chitrakoot Judgeship for His Lordship's kind perusal and orders?
