May kindly see the property statement received online from Smt. Mona Singh, Addl. Civil Judge (Sr.Div.)/ACJM, Lakhimpur Kheri, regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2018-2020 (2018-19 & 2019-20) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial year 2018-2020 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial year 2018-2020 (2018-19 & 2019-20), the Gross income from salary is Rs.17,95,481/- and total deductions/ repayment/ savings/ investment against GIS, PPF, NPS, Car Loan repayments and Income Tax are Rs.8,64,222/- and the balance of her savings bank account is also increased by Rs.5,38,819/- in this financial year from previous year's balance, total of which is Rs.14,03,041/-. Thus, a sum of Rs.3,92,440/- was therefore available with her to meet out the household expenditure of her family consisting three members of the financial year 2018-2020 (2018-19 & 2019-20).

It is also pertinent to mention here that the her husband have annual income is approx. Rs.8,00,000/- through Government Service, for the financial years 2018-19 & 2019-20.

In this connection, it is submitted that the officer has already submitted her movable and immovable property statements of the financial year 2016-2018 (2016-17 & 2017-18), online against Case Id : P00021202021 (Old Case Id : 4247) and the same has been processed before Hon'ble Mr. Justice Abdul Moin, Administrative Judge, Lakhimpur Kheri for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2018-2020 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. She has firstly submitted movable and immovable property statements of the financial year 2018-2020 (2018-19 & 2019-20) vide online dated 09.12.2021. As such, there is delay in submitting the same for which the officer has stated in her statement of joining date (in case Id no.P00018022021 | Old Case Id : 3922) that the reason for being late was the lack of technical knowledge about use of the portal and it took me some time to understand. She apologize for the delay and in future the property statement will be submitted with full sincerity at the end of the financial year.

May, therefore, if approved, property statements for the financial year 2018-2020 (2018-19 & 2019-20) of Smt. Mona Singh, Addl. Civil Judge (Sr.Div.)/ACJM, Lakhimpur Kheri, be laid before Hon'ble Mr. Justice Abdul Moin, Administrative Judge, Lakhimpur Kheri Judgeship for His Lordship's kind perusal and orders?
