May kindly see the online property statement received from Smt. Garima Singh, Additional Principal Judge, Family Court, Aligarh regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial years 2010-11 & 2011-12 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2010-11 & 2011-12 of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

(1) In the financial years 2010-11 & 2011-12, Total income is Rs.26,57,019/- [income from salary & allowances (for both the financial years) are Rs.20,88,451/- and 6th pay commission arrear of Rs.5,68,568/-] and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income Tax, Car loan, PPF a/c, NPS arrear and the balance of her savings bank account(s) is enhanced for Rs.1,18,453/-, total of which is Rs.9,70,601/-. Thus, a sum of Rs.16,86,418/- was therefore available with her to meet out the household expenditure of her family consisting four members in both the financial years.

It is pertinent to mention here that her husband is also in Judicial Service in U.P.

In this connection, it is submitted that the officer has already submitted her property statement upto the financial years 2009-10 which had already been seen by Hon'ble Mr. Justice Abdul Mateen, the then Administrative Judge, Aligarh, placed in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statements of the financial years 2010-11 & 2011-12 in its next financial year i.e., 2012-13 upto March 2013. She has submitted movable and immovable property statements of the financial years 2010-11 & 2011-12 firstly vide online dated 09.12.2021. As such, there is delay in submitting the same from the part of the officer for which she has mentioned in the remark column of movable property statement that "She could not file her property statement in due time because due to transfer relevant paper were lost. She has again collected papers from account section etc. applicant seek unconditional apology for delay."

May, therefore, if approved, property statements of the financial years 2010-11 & 2011-12 of Smt. Garima Singh, Additional Principal Judge, Family Court, Aligarh be laid before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Aligarh Judgeship for His Lordship's kind perusal and orders?
