May kindly see the property statement online received from Shri Saurabh Kumar Verma, Additional Civil Judge (Sr.Div.)/ACJM. Bareilly, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2017-19 (2017-18 & 2018-19) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2017-19 (2017-18 & 2018-19)of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2017-19 (2017-18 & 2018-19), Total income is Rs.17,76,414/- (Gross income from salary is Rs. 17,76,414/-) and total deductions/ repayment/ savings/ investment against GIS, NPS, Income Tax, Home Loan instalments, PPF & various policies and the balance of his savings bank account(s) is increased by Rs.1,76,252/- in this financial year from previous year's balance, total of which is Rs.1074559/-. Thus, a sum of Rs.7,01,855/- was therefore available with him to meet out the household expenditure of his family consisting of three members in both of the financial years.

It is pertinent to mention here that his wife was holding the post of Civil Judge Junior Division but was promoted as Civil Judge (Senior Division)/ A.C. J. M. on 07/01/2019. Her annual income for the year 2017-2018 was 5,36,408/- and for the year 2018-2019 was 7,55,131/-.

In this connection, it is submitted that the officer has already submitted his property statement for the finacial years 2015-2017 (2015-2016 & 2016-2017) which has already been seen on eservice-Id no:P00000152020 (Old Case Id: 519) by Hon'ble Mr. Justice Ashwani Kumar Mishra, the then Administrative Judge, Bareilly.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2017-19 (2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements of the financial years 2017-19 (2017-18 & 2018-19) vide online dated 09/12/2021. As such, there is some delay in submitting same. In this regard, officer has stated that because of work load and family reason he could not submit the property statement in time, and also requested to accept his apology.
