May kindly see the property statements online received from Sushri Priyanka Singh, Chief Judicial Magistrate, Ambedkar Nagar at Akbarpur regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial years 2017-19 (2017-18 & 2018-19) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2017-19 (2017-18 & 2018-19) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

In the financial years 2017-19 (2017-18 & 2018-19), Gross income is Rs.21,85,816/- (income from salary Rs.20,55,816/- & income from agriculture Rs.1,30,000/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income Tax, PPF, FD, LIC Policy, Tanishq Golden Harvest scheme and the balance of her savings bank account(s) is enhanced for Rs.6,83,991/-, total of which is Rs.12,44,808/-. Thus, a sum of Rs.9,41,008/- was therefore available with her to meet out the household expenditure of herself in both the financial years.

In this connection, it is submitted that the officer has already submitted her property statement upto the financial year 2016-17 which had already been approved by Hon'ble Mr. Justice Vivek Kumar Birla, the then Administrative Judge, Kannauj with the order "A word of caution be issued to the officer to submit reports within time" in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2017-19 (2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto March 2020. She has submitted movable and immovable property statements for the financial years 2017-19 (2017-18 & 2018-19) vide online dated 08.12.2021. As such, there is delay in submitting the property statement from the part of the officer. In this regard, she stated that she could not submit the same on time not due to her carelessness but it occurred due to Covid pandemic and illness of her mother & brother, for which she apologizes.

May, therefore, if approved, property statements for the financial years 2017-19 (2017-18 & 2018-19) of Sushri Priyanka Singh, Chief Judicial Magistrate, Ambedkar Nagar at Akbarpur be laid before Hon'ble Mr. Justice Deepak Verma, Administrative Judge, Ambedkar Nagar Judgeship for His Lordship's kind perusal and orders?
