May kindly see the property statement submitted online received from Sri Dilip Kumar Sachan, Additional District & Sessions Judge (F.T.C.), Etawah, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2017-19 (2017-18 & 2018-19) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2017-19 (2017-18 & 2018-19) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below:-

In the financial years 2017-19 (2017-18 & 2018-19), his gross income including arrears & allowances is Rs. 27,92,883/- total deductions/savings/investments against NPS, GIS, Income Tax, Insurances, PPF and the balance of his S.B.A/c has enhanced for Rs.9,26,441/- this financial years against the balance of previous year's, total of which is Rs.18,72,579/-. Thus a balance of Rs. 9,20,304/- was therefore available with him to meet out the household expenditure of his family consisting of three members in both the financial years.

It is pertinent to mention here that wife of the officer Smt. Shailja Sachan is a lawyer and her annual income is approx one lac per year.

In this connection, it is submitted that the officer has already submitted his property statements of the financial year 2015-17, which has already been seen offline by Hon'ble Mr. Justice Abhai Kumar, the then Administrative Judge, Sonbhadra Judgeship in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2017-19 (2017-18 & 2018-19) in its next financial year i.e.,2019-20 upto 31st March 2020. He has submitted movable and immovable property statements for the financial years 2017-19 (2017-18 & 2018-19) vide his application dated 10.12 2021. As such, there is delay in submitting the same from the part of the officer. In this regard, officer apologizes for not submitting the property statement within the scheduled time due to Covid situation and Covid illness of his father and due to work load property statement could not be submitted within time as prescribed. He also insures that in future the proeprty statement shall be sent by him on proper time and this mistake would not be repeated.

May, therefore, if approved, property statements for the financial years 2017-19 (2017-18 & 2018-19) of Sri Dilip Kumar Sachan, Additional District & Sessions Judge (F.T.C.), Etawah, be laid before Hon'ble Mr. Justice Raj Beer Singh, Administrative Judge, Etawah for His Lordship's kind perusal and orders?
