May kindly see the property statement online received from Sri Hari Prakash Gupta, Additional District & Sessions Judge, Bareilly regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2017-18 & 2018-19 in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2017-18 & 2018-19 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2017-18 & 2018-19, Total income from salary is Rs.35,78,404/- (total Gross income from salary is Rs.30,94,208/-, interests from FDR & Bank a/cs of Rs.73,020/-, maturity of NSC of Rs.1,85,104/-, Maturity of mutual fund of Rs.79,765/- and FDR encashment of Rs.1,46,307/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, PPF, Income Tax, Insurance policies, Car loan, NSC, mutual fund, FDR and RD are Rs.17,34,422/-. Thus, a sum of Rs.18,43,982/- was therefore available with him to meet out the household expenditure of his family consisting three members in both the financial years. And the balance of his savings bank account(s) is also reduced for Rs.60,594/- this financial year from previous year's balance.

In this connection, it is submitted that the officer has already submitted his property statement at the time of entering into Judicial Service which had already been seen by Hon'ble Mr. Justice Devendra Kumar Arora, the then Administrative Judge, Shrawasti, placed in the misc. file of the officer And property statements of the financial years 2009-11 & 2011-13, which had already been laid offline before Hon'ble Mr. Justice Ajit Kumar, Administrative Judge, Bareilly Judgeship for His Lordship's kind perusal and orders, placed in the misc. file of the officer. And for the financial years 2013-15 & 2015-17, detailed notes have been submitted before Hon'ble Mr. Justice Ajit Kumar, Administrative Judge, Bareilly Judgeship for His Lordship's kind perusal and orders on e-service IDs P00017972021 & P00024752021 respectively.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2017-18 & 2018-19 in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements of the financial years 2017-18 & 2018-19 vide online dated 11.12.2021. As such, there is delay in submitting the same from the part of the officer for which he has stated that "due to repeated illness of his father, he was busy in arranging his treatment, Later on unprecedented outbreak of Covid 19 Pandemic. Due to above reasons, he could not submit statement within time, for which he is deeply regretted.", mentioned in remark column of movable proforma.

May, therefore, if approved, property statements of the financial years 2017-18 & 2018-19 of Sri Hari Prakash Gupta, Additional District & Sessions Judge, Bareilly be laid before Hon'ble Mr. Justice Ajit Kumar, Administrative Judge, Bareilly Judgeship for His Lordship's kind perusal and orders?
