May kindly see the property statement online received from Sri. Parvendra Kumar Sharma, Judge, Special Court, CBI Court No. 2, Ghaziabad regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-20(2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20(2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

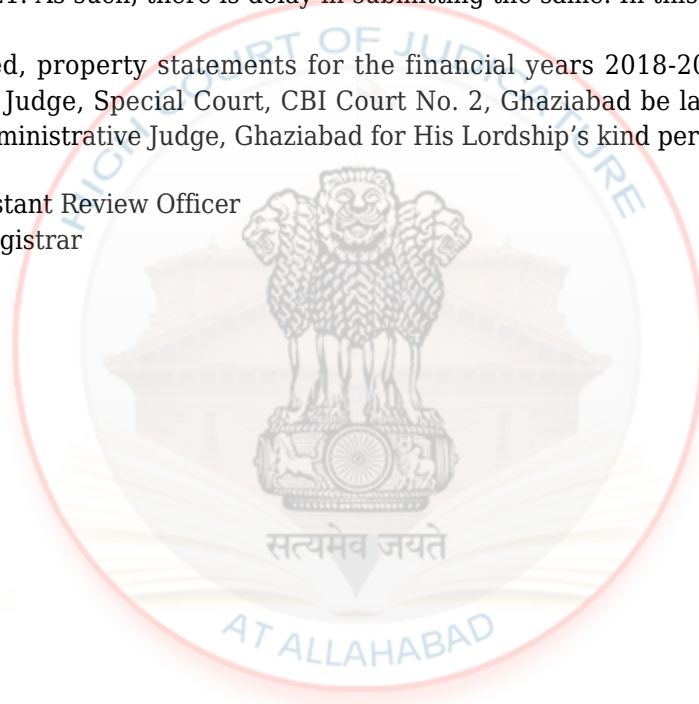
(1) In the financial years 2018-20(2018-19 & 2019-20), Total income is Rs.42,34,809/- (Gross income from salary is Rs.41,01,467/-, Bank Interest is Rs.18,767/- and FDR Interest is Rs.1,14,575/-) and total deductions/ repayment/ savings/ investment against NPS, GIS, Income Tax, PPF, FDR, NSC, LIC Policy's, Car Loan EMI, HDFC Life Insurance, SBI Life Insurance, Medical Insurance and the balance of his savings bank account(s) is enhanced by Rs.2,48,544/- this financial year from previous year's balance, total of which is Rs.28,09,318/-. Thus, a sum of Rs.14,25,491/- was available with him to meet out the household expenditure of his family consisting of four members in both of the financial years.

In this connection, it is submitted that the Officer has already submitted his property statements of the 2017-19 (2017-18 & 2018-19) offline and same has been approved by the Hon'ble Mr. Justice Pankaj Naqvi, the then, Administrative Judge, Budaun Judgeship in Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20(2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-20(2018-19 & 2019-20) vide online dated 09.12.2021. As such, there is delay in submitting the same. In this regard officer has stated that "Sorry for late submission".

May, therefore, if approved, property statements for the financial years 2018-20(2018-19 & 2019-20) of Sri. Parvendra Kumar Sharma, Judge, Special Court, CBI Court No. 2, Ghaziabad be laid before Hon'ble Mr. Justice Attau Rahman Masoodi, Administrative Judge, Ghaziabad for His Lordship's kind perusal and orders?
