May kindly see the online reply received from Sri Devesh Chandra Gupta, the then Additional District & Sessions Judge (F.T.C), Kaushambi, now posted as A.D.J.(FTC), Lucknow, in compliance of order of Hon'ble Mr. Justice Samit Gopal, the then Administrative Judge, Kaushambi Judgeship in the matter of property statements held at the time of entering i.e., of joining into U.P. Judicial Service, communicated to the officer.

In this connection, it is submitted that the officer had submitted his movable & immovable property statements held at the time of entering i.e., of joining into U.P. Judicial Service, which was put up before Hon'ble the Administrative Judge, Kaushambi through detailed office note, on which His Lordship has been pleased to pass the following order dated 25/03/2023:

"There is delay in filing of the property staement from the date of joining itself.

## Let the delay be explained."

The order of the Court has been communicated to the officer concerned on 26/03/2023.

In compliance of the Hon'ble Court's Order, the officer concerned has submitted his reply on dated 02.04.2023, wherein he has stated (in his verbatim) that :

"..the delay in submitting the property statement at the time of joining was due to preoccupation with training both institutional and field, and due to prevalence of pandemic (Covid-19) with undersigned himself being covid positive, which hampered the collection of desired information.

Inconvenience caused to your goodself is highly regretted for which my unconditional apology is being tendered herewith. Kindly place the same before the Hon'ble Court for kind perusal."

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement held at the time of joining into judicial service just after joining into U. P. Judicial Service. His joining date is 03/06/2020. He has submitted the aforesaid statement firstly on 09/12/2021. As such, there is delay in submitting aforesaid property statement from the part of the officer. In this regard, officer has given the reason for delay in compliance of the Hon'ble Court's order.

May therefore, if approved, movable & immovable property statement held at the time of entering i.e., of joining into U.P. Judicial service alongwith the reply/ compliance of Hon'ble Court's order, as desired by the Court in the matter, furnished by Sri Devesh Chandra Gupta, A.D.J.(FTC), Lucknow, be laid before Hon'ble Mrs. Justice Sangeeta Chandra, Administrative Judge, Lucknow Judgeship for Her Lordship's kind perusal and orders?
