May kindly see the property statement received online from Sri Apoorv Singh, Addl. District & Sessions Judge, Agra, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2015-2017 (2015-16 & 2016-17) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2015-2017 (2015-16 & 2016-17) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2015-2017 (2015-16 & 2016-17), the Gross income from salary is Rs.20,95,381/- and total deductions/savings/investment against GIS, NPS, PPF, Insurances and Income Tax is Rs.7,06,072/- and the balance of his savings bank account(s) is also increased by Rs.5,37,692/- in this financial year from previous year's balance, total of which is Rs.12,43,764/-. Thus, a sum of Rs.8,51,617/- was therefore available with him to meet out the household expenditure of his family consisting four members of the financial year 2015-2017 (2015-16 & 2016-17).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2013-2014 & 2014-2015 offline and the same has been seen by Hon'ble Mr. Justice Vipin Sinha, the then Administrative Judge, Bareilly Judgeship, in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2015-2017 (2015-16 & 2016-17) in its next financial year i.e., 2017-18 upto March 2018. He has firstly submitted movable and immovable property statements of the financial year 2015-2017 (2015-16 & 2016-17) vide online dated 13.08.2021. As such, there is delay in submitting aforesaid property statements from the part of the officer. In this regard, the officer stated in his online reply dated 04.04.2023, that (in his verbatim) "Due to ongoing Pandemic Covid 19, I was unable to submit required document or information. Kindly condoled my delay".

May, therefore, if approved, property statements for the financial year 2015-2017 (2015-16 & 2016-17) of Sri Apoorv Singh, Addl. District & Sessions Judge, Agra, be laid before Hon'ble Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Agra Judgeship for His Lordship's kind perusal and orders?
