May kindly see the property statement online received from Sri Dinesh Kumar-II, Additional District & Sessions Judge (F.T.C.), Kushi Nagar at Padrauna regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2017-19(2017-18 & 2018-19) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2017-19(2017-18 & 2018-19) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years, 2017-19(2017-18 & 2018-19) officer income from salary & Agriculture is Rs.33,64,689/- and total deductions/ repayment/ savings/ investment (for both the financial years) against NPS, GIS, Income Tax, Insurance policies, and PPF is Rs.8,77,466/- . Thus, a sum of Rs.24,87,223/- was therefore available with him to meet out the household expenditure of his family consisting of four members in both the financial years. And the balance of his savings bank account(s) is also decreased for Rs.12,51,6,78/- this financial year from previous year's balance.

It is pertinent to mention here that Wife of the officer is a Asst.Teacher. Her Annual Income from salary Rs.4,50,000/- Approx and Rs.5,30,000/- Approx respective financial years 2017-18 and 2018-19.

In this connection, it is submitted that the officer has already submitted his property statement upto financial year 2015-17 which has already been processed online on case id no.4196 before Hon'ble Mr. Justice Deepak Verma, Administrative Judge, Kushinagar at Padrauna.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2017-19(2017-18 & 2018-19) in its next financial year i.e., 2019-20 i.e. upto March 2020. He has submitted movable and immovable property statements of the financial years 2017-19(2017-18 & 2018-19) firstly vide online dated 09.12.2021. As such, there is delay in submitting the same from the part of the officer for which he has regretted and assured that same will not be repeated in future.

May, therefore, if approved, property statements of the financial years 2017-19(2017-18 & 2018-19) of Sri Dinesh Kumar-II, Additional District & Sessions Judge (F.T.C.), Kushi Nagar at Padrauna be laid before Hon'ble Mr. Justice Deepak Verma, Administrative Judge, Kushinagar at Padrauna Judgeship for His Lordship's kind perusal and orders?
